TERMS & CONDITIONS:-

- This application is made by the Applicant to establish a charge account facility with Executive Hire Cars (1997) Pty Ltd (ABN 19 003 616 420) trading as Sky Park Valet Parking (SPVP) using the Applicants credit or charge card as the method by which accounts will be settled.
2. SPVP will consider the Applicants application and determine at its absolute discretion if facilities will be granted. SPVP may vary, cancel or cease to provide facilities at any time without notice and without any obligation to provide reasons for its decision.
 3. The Applicant agrees not to misrepresent the products and services offered by SPVP at any time and to only offer rates approved by SPVP. The Applicant agrees only to use SPVP's name logo or any other identifying mark with the prior authorisation of SPVP.
 4. The Applicant agrees if charge account facilities are provided to issue a voucher for each parking service to the customer. The Applicant further agrees to advise its client that the voucher must be presented to SPVP failing which SPVP may refuse the service.
 5. The voucher issued by the Applicant must be in a form acceptable to SPVP. It must include as a minimum; Applicant's name and Sky Park account code, Applicant's address, the rate plan name or code, Applicant's voucher number, Customer's name, the number of prepaid parking days, any additional services included, the delivery and collection date, SPVP branch address and contact phone numbers.
 6. The Applicant authorises SPVP to charge the nominated credit/charge card for all parking and related charges at the end of rental. SPVP will include a credit card fee of which it will advise the Applicant from time to time. SPVP will send to the Applicant receipts with details of parking charges and payments made by Applicant's credit card each time a charge is made.
 7. The Applicant must ensure that at all times the credit card have sufficient funds available to permit SPVP to process charges for parking. The Applicant must not cancel the credit card unless it has provided SPVP with an alternative credit card and the Applicant must promptly provide SPVP with the details of an alternate or new credit card prior to the credit card expiry.
 8. The Applicant agrees to pay SPVP an administration fee of AUD\$20 if credit cards charge transaction is declined due to the insufficient availability of credit of the Applicant's credit card. If SPVP is unable to process charges on the credit card for any reason SPVP will inform the Applicant and thereupon the Applicant must make payment by such other method approved by SPVP within seven (7) days. Failing this the Applicant agrees to pay SPVP interest at the rate of twenty percent (20%) per annum (pro-rata per day) of the total monies outstanding plus collection and legal fees.
 9. The Applicant must promptly notify SPVP in writing of changes to the Applicant's business structure or ownership of the business. The Applicant must notify SPVP in writing of any event leading to the insolvency or bankruptcy of any of the directors, partners or principals of the Applicant or any scheme or arrangement made or intended to be with by the Applicant with its creditors.
